Food Vendor Tear Down

No tear down until after the public clears out. Please watch carefully driving on the sidewalk. Plan exit strategy with Event Supervisor, Alyssa Trumbower.

Electricity needs

Food trucks should be self-sufficient and bring generator(s). There might be power plug-ins available.

Notes and Reminders

- Vendors must supply their own tent and/or awning with **weights**, table(s), chair(s), banner(s), and other supplies. Spaces will be marked and a map showing booth location will be provided prior to the event.
- All tents must provide and use weights. Be certain that the weights are sufficient to sustain strong winds that sometimes occur during outdoor events. Vendors are responsible for properly securing their tents. The City of Chaska does not allow stakes.
- All vendors are required to clean their area at the end of the event. If you have large amounts of garbage, please take it to Veteran's Park dumpsters.

Please list all items and prices to be sold or include a sample menu. Please be able to accept cash and credit cards.

Health Permit

All food vendors must be licensed to sell food products and provide a copy of the following licenses with their application:

- State of Minnesota Mobile Food license

Layout/footprint (trailer/trucks only)

Provide layout of trailer/truck. Indicate travel direction and the side that is used for serving. Submit a drawing, picture or a web link showing the trailer/truck. Please email size of food truck and space needed. Event Supervisor will work on logistics and map out where all vendors will be positioned prior to the event. Event Supervisor will help direct where exactly each food truck should park on event day(s).
